1. Summary

Deliverable 9.4 of WP9 was a deliverable requested by the European Commission (EC) during the Grant Agreement Preparation. The request by the EC was to appoint an independent Ethics Advisor with expertise in clinical trials in neonates.

The Consortium, through the Steering Committee, proposed the appointment of Dr Gianluca Lista, chief neonatologist of "NICU and Neonatology," at V. Buzzi Children's Hospital of Milan, at the end of February 2023.

However, the appointment was not followed up, as Dr Lista's profile was not considered by the EC to meet both competence profiles required: namely expertise in research ethics in general and substantive experience in the assessment of ethics issues in the specific topic area of the project in clinical trials with neonates.

In the following months, the consortium members worked to look for and contact experts who could meet both requirements and were willing to participate.

Although multiple professionals were contacted, only 2 of them replied to the contact request and made themselves available for being appointed as Ethics Advisor for the project.

2. Steering Committee decision on Ethics Advisor

The competence profiles of the two available professionals were assessed by the Steering Committee to determine who would be most suitable to be proposed to the Commission as Ethics Advisor.

The Steering Committee met remotely, via email, after preliminarily discussing the issue at the in-person meeting held in Padova, on July 5, 2023.

We report a summary profile of the two possible candidates to the role of Ethics Advisors (see attached CVs):

- Roberto Cippitani is an Italian biolaw Professor working at the University of Perugia with expertise in ethics issues. He has already worked as Ethics Advisor in other European projects and has been an expert evaluator for the European Commission. However, he is not an expert in neonatology and has not worked with neonatologists before. He will act as Ethics Advisor and be supported by the other two experts: Colcelli, PhD, First researcher at CNR and expert on legislation of research and innovation, in particular with respect to the protection of personal data and Langella, PhD, Researcher fellow at Università degli Studi di Perugia, associated researcher of CNR-IFAC, expert of legal aspects of biomedical research (unfortunately her CV, in attachment, is only in Italian).

- Marieke Westerman-den Boer: she is a Dutch ethicist currently working at the Elisabeth-Tweesteden Hospital in Tilburg, the Netherlands. Her PhD dealt with ethical aspects of improving neonatal resuscitation. She has already worked with neonatologists and in delivery room trials but has never worked as Ethics Advisor for the European Commission.

The Steering Committee members who took part in the discussion, voting for one of the options were: Alessandro Torricelli (PI of POLIMI), Turgut Durduran (PI of ICFO), Josep Vehi (PI of UdG), Robert J. Cooper (PI of UCL), Mauro Buttafava (PI of pioNIRS), Idan Tamir (PI of QLAB), Emmanuel Barbier (PI of UGA), Gene Dempsey (PI of UCC), Chiara Dalla Man (substitute PI of UNIPD and chairperson). Stefano Dal Poz (PI of Dave) was absent

Of the Steering Committee members, 8 voted in favour of appointing Dr Marieke Westerman-den Boer as Ethics Advisor to the Prometheus project, based on both expertise and focus on the specific topic required by the EU.

The Coordinator did not express any vote and DAVE did not attend the meeting, but sent an email after the voting was concluded, to express their agreement on the candidate chosen by the consortium

As a result, the Steering Committee decided to propose the appointment of Dr Marieke Westerman-den Boer as Ethics Advisor to the Prometheus project.

3. Integration required

Following the evaluation of the proposal profile by the Steering Committee, the European Commission asked the consortium to provide some additional information and clarifications, as well as a declaration of independence and absence of conflicts of interest to be signed by the proposed Ethics Advisor.

Below is additional information regarding Dr. Westerman-den Boer.

3.1.2 Area of expertise and concise description of educational and professional background (clearly specifying their background in clinical trials with neonates and ethics training)

Dr. Westerman-den Boer is an ethicist currently working at the Elisabeth-Tweesteden Hospital in Tilburg, the Netherlands. Her PhD dealt with ethical aspects of improving neonatal resuscitation. Throughout her PhD, Marieke was a member of the research team of Prof. Arjan te Pas, which conducted various clinical trials in the delivery room and the NICU (see Te Pas AB[Author - Last] - Search Results - PubMed (nih.gov) for more information). As a member of this research team, she was involved in various activities related to the conduct of clinical trials, including the establishment of study protocols, providing ethical advice on study protocols, setting up study equipment, approaching parents for informed consent for study participation, and data management.

From 2018 to 2020 she was Ethics member Young European Academy of Pediatrics.

Dr Westerman-den Boer obtained her Bachelor's degree in Medicine from Leiden University in the Netherlands in 2014, with a scientific internship on The role of parents in decision-making regarding extreme prematurity; a qualitative regional Dutch study.

She then continued her studies with a Master's degree in Religious Studies in 2016, and in the same year completed postgraduate training in Spiritual Counselling at the University of Utrecht.

3.1.4 Description of the independent Ethics Advisor's / Board's mandate, including starting and ending dates of involvement

The Ethics Advisor should advise the Consortium on ethical issues that may arise during the project and assist in efforts to pre-empt problems and propose possible solutions.

The Ethics Advisor commits herself to do whatever is necessary to monitor the aims, objectives, methodology and impact of the research to ensure that it conforms to the highest ethical standards and applicable EU, international and national legislation on ethical principles, thereby assisting the Commission and its Executive Agencies in ensuring that the work of the project does not expose researchers, research participants or the general public to activities that would be considered ethically unacceptable or even prohibited.

She should provide independent recommendations, advice on authorisation requirements, risk-benefit assessments, guidance on specific ethical issues and guidance on the relevant legal and regulatory framework in the countries where the project activities take place. Any ethical advice given by the Ethics Advisor must be based on, and not in conflict with, EU/national law.

In particular, she will be asked to assist the consortium, and especially the partners more involved in the in-human study, to submit the in-human study protocol to the ethics committees, taking into account that the regulatory environment in which the project operates is international and that the devices will be manufactured in several EU and non-EU countries.

The Ethics Advisor will maintain regular contact with each partner with work package responsibilities for ethics-related activities; both need to be kept informed of each other's activities and plans.

The Ethics Advisor should, as far as possible, ensure that there is consistency of advice and practice, and is also invited to provide advice, monitoring and recommendations for future work.

Where appropriate, the Ethics Adviser should be able to attend project meetings, have access to technical reports and papers for publication, and monitor all authorisations, approvals and licences. She will also report to the Funding Body on the project's compliance with ethical standards. Reports by the Ethics Advisor on how the ethical issues raised by the project have been addressed must be submitted at M30 and at the end of the study.

The expert will start her mandate right after the approval of D 9.4. The mandate will end at the end of the project, after the submission of the final scientific report and approval by the funding body.
